Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to Alderity.com, and Alderity LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Alderity LLC include Alderity.com, Alderity, Alderity.co.il and my.Alderity.com. The Alderity website is a WordPress and servers hosting provider site. By using the Alderity website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Alderity may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Job Title

If you purchase Alderity's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Alderity may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Alderity's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. Use of your Personal Information

Alderity collects and uses your personal information to operate and deliver the services you have requested.

Sharing Information with Third Parties

Alderity does not sell, rent or lease its customer lists to third parties.

Alderity may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Alderity, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Alderity. Use of Cookies

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
